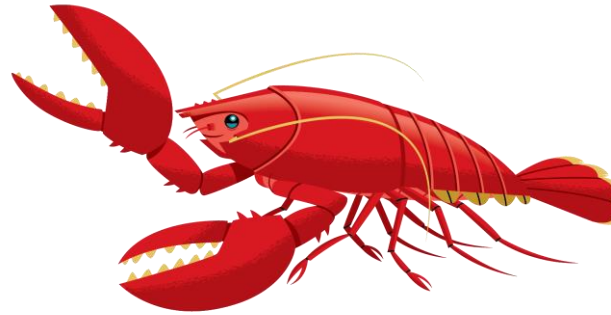

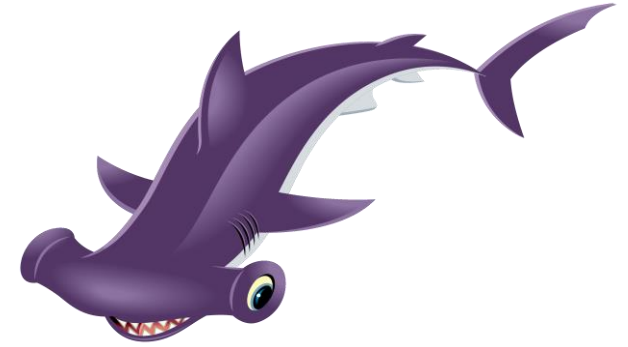

Pleasant Valley Bible Church VBS Medical/Liability Release Form, Effective July 24-July 28, 2023

The intent of this Liability Release is to prevent Pleasant Valley Bible Church, its owners, agents, assigns, employees, staff, and volunteers (hereafter "the Church") from being held liable for injuries to person or property when users of our facilities are injured as a result of their being present on our ground whether or not they are engaging in an activity which the church allows. Your signature on this Liability Release constitutes your agreement and the agreement of your child for whom you are signing this Release, not to hold the Church liable for damages, losses or injuries to person or property, including the results of negligence or other wrongful part on the part of Church, in connection with the 2023 VBS program, including any injuries or losses, sickness, or death from contracting or exposure to the COVID19 virus or any of its variants. As parents or guardians of the child registered for the VBS program herein, you understand that you are signing for the minor listed on this form and that you further understand that signing this Liability Release constitutes a full and complete release from liability insofar as the Church is concerned and an agreement to hold said Church harmless and relieved of any responsibility for any injury or damage to your child or property. In addition, by signing this form, you acknowledge and agree that any video or photos taken of your child may be used in publications or promotions (i.e. print, video, or internet form) for Pleasant Valley Bible Church and its related ministries without compensation to you, your agents, or your heirs.
